Re: Web-based Program Updates and June 30th Outage Planned

As you probably know by now, web-based programs for the Kentucky Treatment Outcome Study, including both a version for adults ages 18 and older (KTOS) and adolescents ages 12-17 years old (AKTOS), are now available to use instead of the PDA-based programs. Changes based on feedback from users like you and from the Division of Behavioral Health have recently been made to the interview formats and are now ready for use.

1. Please note that we will NOT be able to use any PDA-based data collected after June 30. On July 1, you MUST switch to the web-based surveys in order to enter data.

Please synch the last of your PDA data to us by July 15 then mail or bring back your old equipment.

2. IMPORTANT: In order to install the updated programs, there will be **no access** to the web-based programs all day on June 30<sup>th</sup>. Access will resume normally on July 1.



3. When you open the web-based program again on **July 1** to complete an interview with a client, the programs will be the new revised versions and may look slightly different. A summary of the key changes made to the series of questions are listed below:

## Questions involving the following have been removed:

- Driver's license, car ownership
- Specific prescription medicines used for pain
- Lifetime substance use and mental health histories
- Domestic violence order status (EPO/DVO)
- Criminal convictions in past 12 months and time spent in jail in past 30 days
- Presence of current alcohol and/or drug users in home
- Religious affiliation

## Questions involving the following have been added:

- Height/weight for calculation of BMI and health status measures
- Chronic medical problems and medical insurance status
- · Age first used tobacco, alcohol, and illicit drugs; number of cigarettes smoked per day; binge drinking
- Measures of stress and its impact
- In place of current ASI mental health questions, DSM IV Mental Health Measures (depression, anxiety, suicidal ideation) for adults and GAIN-Q Total Symptom Severity Scale for adolescents

## Questions were also updated to include more specific and understandable wording for the following items:

- Description of place of employment, work roles; Reason for unemployment
- Number of children, their ages if under 18, and if the child lives with the respondent
- Arrest categories (reduced to the 7 major crime categories with specific examples
- Living situation questions including homelessness
- **4.** Internet page links remain the same for both intake interviews and are also available on the KTOS homepage (www.cdar.uky.edu/ktos).

5. It is recommended that you use Firefox as your web browser. You can download the browser for free (<a href="http://www.mozilla.com">http://www.mozilla.com</a>). Internet Explorer has a history of conflicts with web-based survey software and may slow down your system. If you do want to use Internet Explorer, please make sure it is version 7 or higher. Watch the KTOS web page for more information and tips over the next few months.

Please share this information with your staff at all treatment sites if they have responsibility for completing adult or adolescent KTOS intake interviews with clients. The length of the intake interview remains about 20-30 minutes, though the content has changed to provide the state with more accurate outcome measures and national comparison potential. Thank you for your work and support for Kentucky's treatment outcome studies!
