On March 6, 2020, the Governor issued Executive Order 2020-215, declaring a state of emergency pursuant to his power under the Kentucky Constitution and KRS Chapter 39A regarding COVID-19, a mild to severe respiratory disease that can result in death.

In recognition of that order, we are taking necessary steps to protect the health of our fellow Kentuckians by engaging in "social distancing" and limiting person-to-person contact in the workplace.
