



The first Surgeon General's report linking cigarettes with lung cancer is released. The number of smokers starts to drop.

1965 The first warning label appears on all cigarette packs.





1988 Smoking is banned on all flights in the USA

1971

Cigarette advertising is banned on radio and television.



1998

The Master Settlement Agreement (MSA) requires tobacco companies to pay \$229 Billion to 52 states and territories over many years to compensate them for costs of treating smoking related illness.

The MSA also contains three main categories of restrictions:

- Advertising Restrictions
- Name Brand Recognition
- Give-away Restrictions

2003

- Delegates from 171 nations approve the world's first international tobacco treaty.

2006

 The Surgeon General report states "... the debate is over." The science is clear: secondhand smoke is not a mere annoyance, but a serious health hazard that causes premature death and disease in children and nonsmoking adults."

2014

- The Health Consequences of Smoking 50 Years of Progress: A Report of the Surgeon General released.
 - Since the first report, more than 20 million American have died from smoking
 - If current rates continue, 5.6 million Americans younger than 18 who are alive today will die prematurely from smoking-related causes
 - Since the first report, 2.5 million non-smokers have died from exposure to secondhand smoke
 - The tobacco epidemic was initiated and sustained by the tobacco industry, which deliberately misled the public about the risk of smoking cigarettes







Smoking Is Responsible for...

- 87% of lung cancer deaths
- 32% of coronary heart disease deaths
- 79% of all cases of chronic obstructive pulmonary disease (COPD)
- 1 in 3 cancer deaths
- Diabetes mellitus, rheumatoid arthritis and immune system weakness, increased risk of tuberculosis disease and death, ectopic (tubal) pregnancy and impaired fertility, cleft lip and cleft palates in babies of women who smoke during early pregnancy, erectile dysfunction, and age-related macular degeneration

SECONDHAND SMOKE

The Environmental Protection Agency has classified secondhand smoke as a group A carcinogen: a substance known to cause cancer humans for which there is no safe level of exposure. Other group A carcinogens include arsenic, asbestos, benzene, and radionuclide, and radon.

Secondhand smoke is the third leading cause of preventable death in the United States.

Can Ventilation Protect the Health of Nonsmoking Workers, Adults and Children?

Ventilation systems can reduce the cancer risk from tobacco smoke to federally (US) accepted levels; however, the ventilation rate required to reach the accepted levels would create a... "virtual windstorm indoors."



- *Lead (banned from paint products)
- *Formaldehyde (embalming fluid)

*Arsenic (rat poison) *Cyanide (used in the gas chamber) *Nitrosamines (potent cancercausing agents)



Spit tobacco has over 3,000 chemicals including 28 known carcinogens.

An average size "dip" of spit tobacco in the mouth for 30 minutes delivers as much nicotine as three cigarettes.








A "pellet" or tablet that looks like a breath mint

- 15 Orbs per package
- 1 milligram of nicotine per Orb
- Equivalent: Approximately 1 cigarettes.

Origin of E-cigarettes




Hon Lik, a Chinese pharmacist inventor of the modern electronic cigarette. •Father died of smoking-induced lung cancer

- Tried to quit his pack-a-day habit
- Invented the ecigarette in 2003

ELECTRONIC CIGARETTES

Use of a heating element to vaporize nicotine and other ingredients, simulating the visual, sensory and behavioral aspects of smoking without the combustion of tobacco



The Many Looks of E-cigarettes



The components

- Tank
- Battery (which heats to over 1,000 degrees Fahrenheit
- Atomizer (heating element)
- Liquid nicotine or e-juice
- Mouthpiece


What they are not telling you...

- THEY HAVE NOT BEEN <u>TESTED</u> - No one knows the health effects.
- THE CARTRIDGES AND VAPOR CONTAIN NICOTINE, CARCINOGENS, FORMALDEHYDE and PROPYLENE GLYCOL - known to cause eye and respiratory irritation
- Labeling may not match contents





- The higher the voltage and hotter the temperature, the levels of harmful chemicals increase
- Nicotine is addictive
- Liquid nicotine is extremely toxic if swallowed or in contact with skin
- Users end up smoking more often and using more nicotine
- <u>"Secondhand Aerosol"</u> or "passive vaping" exposes non-users to tiny particles of heavy metals and other toxins that damage the lungs

Secondhand Aerosol...

- Contains nicotine, ultrafine particulates and toxins that are know to cause cancer
- Concentration of ultrafine particles is higher than in cigarette smoke
 - May exacerbate respiratory ailments like asthma, and constrict arteries which could trigger a heart attack
- At lest 10 chemicals are known carcinogens and reproductive toxins(also found in secondhand smoke)
 - Acetaldehyde, Benzene, Cadmium, Formaldehyde, Isoprene, Lead, Nickel, Nicotine, N-Nitrosonornicotine, and Toluene
- Contains and emits propylene glycol (creates vapor)
 - Short-term -- Eye, throat, and airway irritant
 - Long-term Can result in children developing asthma




US students exposed to e-cigarette advertisements, by school type and number of sources of exposure








Percentage of students who reported using an e-cigarette in the past 30 days (KIP 2014)







- E-cigarettes are tobacco products (Sottera Inc. v Food & Drug Administration, 10-5032, U.S. Court of Appeals, District of Columbia Circuit)

Florida man in coma after e-cigarette explodes in his face

21 year-old Evan Spahlinger was badly burned when his e-cigarette exploded burning his face and throat. According to the hospital, Evan has internal and external burns and damage to his lungs from the explosion itself. They believe that the mouthpiece of the e-cigarette possibly went down Evan's throat and exploded again. He has been placed in a medically induced coma because of the pain.


